### **Higher Education Emergency Relief Fund (HEERF)**

On March 27, 2020, the federal government enacted the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”). Section 18004 of the CARES Act established the Higher Education Emergency Relief Fund (HEERF). The HEERF provides emergency funding to institutions of higher education, including funds that must go directly to students in the form of emergency financial aid grants for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student’s cost of attendance, such as food, housing, course materials, technology, health care, and child-care).

#### **STUDENT ELIGIBILITY**

To be Eligible, you must:

1. Be currently enrolled at Makana Academy in Calendar Year 2020, and
2. Have incurred an eligible expense related to the disruption of campus operations due to COVID-19, and
3. Must meet eligibility for Title IV funding, and
4. Must meet Satisfactory Academic Progress (SAP).
5. Print out this application and submit it to the Administrative Office at Makana Academy. You will be notified of any awards after a review of your application.
